

VOLUNTEER PATRICK HALLEY PRESENTED WITH A LETTER OF COMMENDATION

On September 4, 2020, Volunteer Patrick Halley was presented with a Chief's Letter of Commendation for Outstanding Work this month.

Patrick developed a School Traffic Safety Awareness Program which was implemented in the city to encourage motorists to be mindful while driving in school zones, warning motorists to pay attention to their speed and be aware of school zones. The program included messaging on 100 yard signs and public service radio announcements.

Working with CST Coordinator Lyn Bryan, Patrick designed a yard sign and a Public Safety Message that was then broadcast and distributed over local radio stations and print media outlets.

"Patrick is exactly who we are searching for when we promote our volunteer program. People that want to make a positive difference in the community and really enjoy facilitating that difference. We are very fortunate to have such a wonderful volunteer program and I am proud of the work Patrick has done. He brings a lot to the table" said Interim Chief Bryan Dorman.

LETTERS OF COMMENDATION AWARDED

This month two Letters of Commendation were awarded, one to Community Services Team Coordinator Lyn Bryan and the other to Det. Christopher Warren.

CST Lyn Bryan received a letter recognizing her for calling in a suspicious person she observed while on her lunch break, which ultimately lead to an arrest of that person. She noted a subject riding a bike in a residential neighborhood carrying a TV. She notified dispatch and followed the subject to a nearby apartment while maintaining a safe distance. Officers located the subject, who had an outstanding felony warrant and he was arrested. The TV, presumed to be stolen, was impounded and an investigation is ongoing.



Detective Warren was investigating a shooting in town. At the time, the victim was unable to provide a statement. Det. Warren was able to piece the investigation together through video surveillance, interviews and good old fashion police work.



He was able to identify and arrest two suspects for attempted murder. In addition, he located the firearm that was used in the crime, in unincorporated Polk County. When the victim was able to speak, the information Det. Warren obtained was confirmed.

SRO Julia Franchetti


SRO Franchetti is also entering her first year as SRO. She will be assigned to Bartow High School. She joined the Bartow Police Department almost one year ago.


