#### SIGNIFICANT ARRESTS:

• PELLEGRINO, Joshua: On Sept. 25, 2018 officers with Bravo Squad encountered Joshua Pellegrino just after he committed felony battery against his wife. When attempting to apprehend the suspect, he barricaded himself inside the residence, claiming to have an AR-15 and a Glock 40. After a lengthy stand-off PCSO SWAT Team was notified and then entered the residence and safely removed Pellegrino.

#### DETECTIVE BUREAU-SGT. ERIC SHEROUSE EDUCATION:

Det. Fender completed Interviews and Interrogations School at Polk State College. Det. Vaughn enrolled at Saint Leo University and began his studies in Criminal Justice, pursuing a Bachelor's Degree in Homeland Security.

Detectives and Crime Scene personnel completed Risk Protection Order Training. CST Lloyd completed Basic Crime Scene Training with Officer Brown.

#### SIGNIFICANT ARRESTS:

- WIGGINS, Azinde: Burglary to a Conveyance, Petit Theft relative to two(2) burglaries in Sector 26A (Zone 1).
- VAUGHN, Jonathan: Discharging a Firearm in Public, Possession of Firearm by a Convicted Felon relative to a shooting incident which occurred in Azalea Gardens in July. Vaughn is currently being held on Armed Robbery charges from the prior month.
- WILLIS, Derek: Possession of Methamphetamines and Drug Paraphernalia.
- PELLEGRINO, Joshua: Felony Battery Domestic Battery, Burglary of a Dwelling, Felony Criminal Mischief and Resisting an Officer w/o Violence. On 09/25 at approximately 3:40 PM officers began investigating a Domestic Violence incident which reportedly occurred at 1185 Britts Lane. After interviewing the victim and obtaining medical treatment for her injuries, officers attempted to make contact with the suspect, Joshua Pellegrino at the home on Britts Lane. Pellegrino refused contact and ultimately barricaded himself within the home. After establishing verbal contact, Pellegrino alleged that he was armed with a firearm and would not be taken into custody. Based on this information, Detectives obtained a warrant for Pellegrino's arrest and PCSO SWAT members responded. Bartow Police Department secured the scene, evacuated surrounding residences and continued to converse with the suspect until the arrival of the SWAT team. At 11:55 SWAT members made entry into the residence and Pellegrino was taken into custody, concluding a nearly 7 hour standoff in which all negotiations with Pellegrino failed.


### **Does Neighborhood Watch Work?**


